BAC RESOLUTION AWARDING TO JONECO TECH MARKETING CORP. AS THE SECOND LOWEST CALCULATED AND RESPONSIVE BID FOR THE SUPPLY AND DELIVERY OF LAPTOPS FOR SOCIAL PENSION STAFF

ITB NO. 2024-05-11 (PR No. 2024-03-0270)

WHEREAS, the Department of Social Welfare and Development Field Office X advertised the Invitation To Bid for the Supply and Delivery of Laptops for Social Pension Staff with Approved Budget for the Contract of ONE MILLION SIX HUNDRED PESOS (PHP 1,600,000.00) and posted the same in the DSWD website, in the PhilGEPS and at the conspicuous places and premises of the DSWD Field Office X, Upper Carmen, Cagayan de Oro City;

WHEREAS, on 02 July 2024, the Bids and Awards Committee (BAC) held a Pre-bid conference for the said project through virtual meeting attended by two (2) prospective bidders;

WHEREAS, the opening of bids was held on 15 July 2024 at the DSWD Conference Room, DSWD Field Office X, Cagayan de Oro City with three (3) participating bidders;

WHEREAS, on 05 August 2024, the detailed Bid Evaluation as to technical eligibility was prepared and presented by Atty. Jamenah Marie M. Balindong, BAC TWG, the financial eligibility was prepared and presented by Ms. Hanilyn T. Cimafranca, BAC TWG, and the technical specifications was prepared by Mr. Roniel P. Tabar, BAC TWG and presented by Mr. Paolo S. Butaslac, (as attached);

WHEREAS, per Technical Working Group report, the technical and financial documents submitted by JONECO TECH MARKETING CORP. for the Supply and Delivery of Laptops for Social Pension Staff as the second lowest calculated bid were found to be compliant and is subject for Post Qualification:

WHEREAS, the team conducted the post-qualification to Joneco Tech Marketing Corp. on 14 August 2024, composed of Mr. Arnel V. Radaza, BAC TWG, Mr. Paolo S. Butaslac, End-User Representative, and Ms. Cherrey Maye E. Kilem, BAC Secretariat. Based on the actual and collateral information gathered, the bidder's documents were found compliant as to eligibility, technical and financial documents needed for the awarding of the project to Joneco Tech Marketing Corp.;

WHEREAS, on 20 August 2024, the post-qualification report was rendered by Ms. Cherrey Maye E. Kilem, (as attached);

WHEREAS, Ms. Bellene L. Ahmad, BAC 2nd Vice-Chairperson, made a motion to award to JONECO TECH MARKETING CORP. being the lowest calculated and responsive bidder with their bid amount of ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP



1,500,000.00) for the Supply and Delivery of Laptops for Social Pension Staff and was duly seconded by Ms. Delia A. Maravillosa, BAC Member;
