In lieu of the Supplier/ Manufacturer's Certificate, the Supplier may inform the Architect and Engineer of the construction materials being delivered prior to its actual delivery.
<b>Section IX – Checklist of Technical and Financial Documents</b>	Site Visit/Inspection	The Site Visit/Inspection Certificate is an eligibility requirement incorporated in the bidding documents and its absence thereof will be a ground for disqualification.
