<b>Schedule of Delivery</b>	How is the delivery? Does it have a schedule?	Delivery will be scheduled every Monday. The winning bidder will be provided a segregated quantity per item per delivery sites.
<b>Kaldero</b>	What is the dimension of Kaldero?	Length: Diameter at least 14 inches Height: at least 9 inches
<b>Envelopes</b>	What will be the color of overall bid component envelope?	For the Overall Bid Component Envelope, <b>any color</b> will be accepted, provided that the bidder shall conform to the required color coding of the Original, Copy 1, and Copy 2 Envelopes.


**Amendments/Changes in the Bidding Documents**

<b>Technical Component Envelope</b>	Only one (1) set of technical component envelope may be submitted in the event of multiple lots to be bid, provided that each lot is specified in the technical documents.	The prospective bidder may opt to submit one set (1 original and 2 duplicate copies) of technical documents, provided that each lot is specified in the technical documents to be submitted.

**Submission of documents that did not reflect the amendment/changes shall be ground for disqualification.**

This Bid Bulletin shall form part of the bidding documents.
