BAC RESOLUTION AWARDING TO WDC BUILDERS AND SUPPLIES AS THE LOWEST CALCULATED AND RESPONSIVE BID FOR THE CONSTRUCTION OF WAITING AREA AND COVERED PATHWAY OF CIU

WHEREAS, the Department of Social Welfare and Development Field Office X advertised the Invitation To Bid for the **Construction of Waiting Area and Covered Pathway of CIU** with Approved Budget for the Contract of **One Million Eight Hundred Thousand Pesos (PHP 1,800,000.00)** and posted the same in the DSWD website, in the PhilGEPS and at the conspicuous places and premises of the DSWD Field Office X, Upper Carmen, Cagayan de Oro City;

WHEREAS, on **4 December 2023**, the Bids and Awards Committee (BAC) held a **Pre-bid** conference for the said project through virtual meeting attended by two (2) prospective bidders;

WHEREAS, the **opening of bids** was held on **18 December 2023** at the DSWD Conference Room, DSWD Field Office X, Cagayan de Oro City with five (5) participating bidders;

WHEREAS, on **18 December 2023**, the detailed **Bid Evaluation** as to technical eligibility was prepared and presented by Mr. Ric Vincent M. Dumaog, BAC-TWG and the financial eligibility was prepared and presented by Ms. Hanilyn T. Cimafranca, BAC-TWG, and the technical specifications was prepared and presented by Engr. Mirriam M. Catigbac, BAC-TWG;

WHEREAS, the team conducted the **post-qualification** to WDC Builders and Supplies on **27 December 2023**, composed of Ms. Monavic M. Budiongan, BAC Member, Mr. Arnel V. Radaza, BAC-TWG, Arch. Glenn Dhan Angel C. Ubay-ubay, End-User Representative, Ms. Erea Viege G. Llenares and Ms. Princess M. Gatinao, BAC Secretariat. Based on the actual and collateral information gathered, the bidder's documents were found compliant as to eligibility, technical and financial documents needed for the awarding of the project to WDC Builders and Supplies;


WHEREAS, on **29 December 2023**, the post-qualification report was rendered by Ms. Princess S. Gatinao (as attached);


