### ADDENDUM No. 2022-07-007

This Addendum No. 2022-07-007 was discussed and agreed during the virtual Pre Bid Conference for the **Supply and Delivery of Office Supplies for Pantawid Pamilya Pilipino Program** with Project ID No. 2022-07-0021 and an ABC of Php 1,436,738.00.
