<b>Early Procurement Activity</b>	What do you mean by EPA?	<p><b>Appendix 31 in the 2016 Revised IRR of R.A. 9184:</b></p> <p>EPA shall refer to the conduct of procurement activities, from posting of the procurement opportunity, if required, until recommendation of the Bids and Awards Committee (BAC) to the HoPE as to the award of the contract, for goods to be delivered, infrastructure projects to be implemented and consulting services to be rendered in the following fiscal year, pending approval of their respective funding sources.</p> <p>The award of contract for Procurement Projects undertaken through EPA may be made only upon approval and effectivity of their respective funding sources, to wit: (i) GAA; (ii) Corporate Budget; (iii) Appropriations Ordinance; or (iv) loan agreement in the case of FAPs; or the reenactment of the previous year's budget which constitutes the current year's authorized budget, when authorized by the Constitution, law or rules.</p> <p>PEs are encouraged to undertake EPA to ensure the timely delivery of</p>



		goods, implementation of infrastructure projects and rendition of consultancy services.
	Is this project to be awarded next year?	Notice of Award will be issued to winning bidder upon the approval and effectivity of the GAA.
<b>Exemption from Election Ban</b>	Is this project exempted from election ban?	<p>Section 261 of Omnibus Election Code of the Philippines:</p> <p><b><i>Prohibition against release, disbursement or expenditure of public funds.</i></b> – Any public official or employee including barangay officials and those of government-owned or controlled corporations and their subsidiaries, who, during forty-five days before a regular election and thirty days before a special election, releases, disburses or expends any public funds for:</p> <p>(1) Any and all kinds of public works, except the following:</p> <p>(b) Work undertaken by contract through public bidding held, or by negotiated contract awarded, before the forty-five day period before election: <i>Provided</i>, That work for the purpose of this section undertaken under the so-called “takay” or “paquiao” system shall not be considered as work by contract;</p> <p>This prohibition shall not apply to ongoing public works projects commenced before the campaign period or similar projects under foreign agreements. For purposes of this provision, it shall be the duty of the government officials or agencies concerned to report to the Commission the list of all such projects being undertaken by them.</p>
<b>Site Inspection Certificate</b>	Do we need to attach the site inspection certificate in the bidding documents?	Site Visit/Inspection is a pre-requisite and must be submitted together with the bidding

documents. Non-site inspection will be a ground for disqualification.
