Question/Clarification of the Prospective Bidders

Technical Specifications	What is your definition or specifications of 'Nutri Juice'?	The Nutri Juice referred to in the technical specifications is the Nutri Juice accredited by the DOST-ITDI/DOST-FNRI.
	Regarding the DOST-FNRI certified adopter, does this mean that all combo variants are considered as certified adopter products?	All variants indicated in the technical specifications must be DOST-FNRI Certified Adopter products. But not necessarily certified as "combo", separate certification per item is allowed.
	For the Banana Chips, clarify whether it is required to be approved by DOST or specifically certified by DOST-FNRI	For Banana Chips, it must be certified by DOST-ITDI/DOST-FNRI.
	Since we are the manufacturer, does this mean we must have a DOST certificate for all four variants? If we participate, do we need to have DOST certification for all Combo variants of Alternate Meal and Nutri Juice?	Yes, all participating bidders shall have DOST-ITDI/DOST-FNRI certification for all variants of the Alternate Meal and Nutri Juice combos.
